ould speak with him about what had happened earlier in the night. Mr. Metropoulos said that this was fine and led us into the living room where there was a futon and some chairs. We sat down and I advised Mr. Metropoulos that I wanted to talk to him about what happened. We advised Mr. Metropoulos that he did not have to speak with us and that no matter what he told us we would not be arresting him tonight. He told us that he would speak with us. He then told us that he made a mistake tonight. He stated that when [REDACTED] told him that she was going to take a shower, he went into the bathroom and turned on his camera and placed it on the shelf to record [REDACTED] while she was taking a shower. He told us that this was stupid and that he made a mistake. Mr. Metropoulos showed us the bathroom which was on the first floor and showed us the camera which he stated was in the same place in the bathroom. I observed the camera to be sitting on a towel shelf directly across from the shower. It was a silver point and shoot camera. We then went back into the living room to talk and I advised Mr. Metropoulos that I wanted to give him the opportunity to tell us the truth about some things before they snow balled out of control. I told him that we would be looking into him and he should tell us everything. Mr. Metropoulos admitted to watching pornography but stated that it was all legal adults that he watched. He stated he used sites like Xhampster but that he did not watch child pornography. I asked him if he had been convicted of any crime. He told me no. I then asked him about the conviction in Michigan for Sexual Assault. He told me that when he was 19 years old, a boy made an allegation that he had touched him sexually. He stated that they were able to reach a plea bargain on the charge. Officer Kuhn then asked Mr. Metropoulos if he could talk to her in the kitchen which she did. While they were in the kitchen speaking, I talked to Mr. Metropoulos more. I advised him that I knew that there were more things that he kept secret and that he should cooperate and tell me without his wife there so that we could get them out in the open. Mr. Metropoulos told me that while the boys were sleeping, he felt both of them in the genital area to "see if they were hard." Mr. Metropoulos told me he did not touch them under the pants and did not do anything else with them.
