Because of Metropolitan Jonah's attempts to send Fr. Simeon (Kharon) to the Antiochian Church (see the e-mails below), I and others on the SMPAC feel strongly that the Antiochian Church needs to receive official warning from the OCA regarding the sexual misconduct and other issues surrounding Fr. Simeon. I have already provided a warning to my bishop, His Grace, Bishop Basil (Essey), but something stronger and more official is in order. At the least, I believe that a copy of the official Report of the Special Investigative Committee (which I have attached) needs to be forwarded to Bishop Basil and/or Metropolitan Philip as soon as possible. However, I think it would be best coming directly from an OCA bishop (or even better, the Holy Synod). Please let me know your thoughts as soon as possible on this urgent matter.

Your Grace and SMPAC:

Christ is Risen!

I have disturbing news. Earlier today, His Grace, Bishop Mark, contacted me. He told me that His Beatitude had been in touch with my bishop, Bishop Basil (Essey), regarding Fr. Simeon (Kharon), and he suggested I contact Bishop Basil. I spoke with Bishop Basil late this morning. He told me the following:

1) On Good Friday, Fr. Constantine Nasr, the priest at St. Elijah Orthodox Church in Oklahoma City (an Antiochian parish), called the Chancery in Wichita, inquiring about Fr. Simeon. Apparently, Fr. Simeon was in Oklahoma City and had met Fr. Constantine at a Greek church there. Fr. Simeon subsequently contacted Fr. Constantine and asked if he could serve at St. Elijah. Fr. Constantine, not knowing anything about Fr. Simeon and not having any of his papers, contacted Bishop Basil to ask for guidance. Fr. Constantine told Bishop Basil's assistant that Fr. Simeon had said something about being under Metropolitan Jonah. (Fr. Constantine and Bishop Basil never talked; all communication was through Bishop Basil's assistant.)

2) Because Fr. Simeon did not have any papers and because neither Bp. Basil nor Fr. Constantine even knew if Fr. Simeon was an Orthodox priest, Bishop Basil (through his assistant) told Fr. Constantine that Metropolitan Philip should handle this matter.

3) On the evening of Great and Holy Saturday, Bishop Basil received an e-mail from Metropolitan Jonah, along with copies of Fr. Simeon's papers (in Greek and English). The e-mail is below. The papers are attached. Bishop Basil did not know why Metropolitan Jonah contacted him directly, since the matter was supposed to have been handled by Metropolitan Philip.

4) At some point (probably before receiving the e-mail from Met. Jonah), Bishop Basil was talking with Bishop Mark and inquired why, if Fr. Simeon was under Met. Jonah, he had not been scheduled to serve in an OCA parish during Holy Week, because there are

several OCA parishes in Oklahoma in need of priests. That is how Bishop Mark became aware of the e-mail from Metropolitan Jonah to Bishop Basil.

5) Bishop Basil does not know whether Fr. Simeon served in OKC, but he doesn't think he did. Bishop Basil stressed to me that Fr. Constantine was "innocent" in all of this.

Bishop Basil has given me permission to share the e-mail from Metropolitan Jonah with you and others, and to provide the background behind Metropolitan Jonah's e-mail.

This is, quite obviously, very concerning, particularly Metropolitan Jonah's statement that Fr. Simeon "has been greatly slandered," the implication that Metropolitan Jonah would have received Fr. Simeon into the OCA but for the slander, and Met. Jonah's continued attempts to find a good position for Fr. Simeon. This new information needs to be provided to the Holy Synod. I'd be interested in your thoughts on when and how to notify the Holy Synod.
