*Dear Romanians, lovers of Orthodox Church, of True Faith, of Romanian Nation and Language!*

With the utmost chosen spiritual joy and with Christian love, I would like to bring my gratitude to the Almighty God, Who is helping me compiling these articles for publication in the CURENTUL INTERNATIONAL magazine and strengthens me in the current struggle for a leading publishing and knowledge of the truth by the readers of this magazine.

Meanwhile, with all due respect, I come to meet you, dear readers, (as I was asked by publishing and reading articles on the months May to August 2010, in the "CURENTUL INTERNATIONAL", under the generic series entitled "**CALVARY OF PAIN AND TRUTH**," with a very interesting new article.

As I said in the past tense, the publishing and information of this process will be long, auspicious, and I hope to produce the expected result, highlighted in previous articles.

Publication of the article "marathon" of previous numbers, brought more light to those who had little or no information regarding those where, I, Fr Vasile Susan went with my family, where we have endured during the period when I was driven out by unfair abuse of power (March 1, 2004), where I was put in charge by God to be the pastor on the way of salvation to those who were entrusted to my spiritual care, the believers from the Romanian Orthodox Church / Parish of St. Mary, Chicago, IL.

I looked to be in agreement with the present tense situation, and to ask you before your eyes quotation from **Psalm 34, verses 1-8**, as shown in the "motto" at the beginning of this article. I chose this quote from the Great Psalter David not accidentally, but with very appropriate and good intentions, having regards to *the three documents* known to you, to be associated with the content of verses **1 - 8, Psalm 34**.

Since I arrived in the state of freedom, issued by Archbishop of dictatorial yoke from Vatra Romaneasca, often passing through the doors of the Court in Chicago, I pondered deeply how God reveals truth in time, to those who want to know the truth, I, Rev Fr Vasile Susan am chief among them. To my surprise, when the file in the Civil Court in Chicago got attention, as it can be seen on [www.rocpnews.blogspot.com](http://www.rocpnews.blogspot.com), or [www.pokrov.org](http://www.pokrov.org), I was attentive to what God revealed to me and showed me that I must know and follow.

To break the ice as soon as possible and to speak on the subject, I come to meet readers of this article with **BREATH - TAKING REVELATIONS**, which will make many people wonder: **IS IT HAPPENED THAT WAY? The documents speak!** The Archbishop / dictator and less honest leader of the ROEA, along with less faithful bishops of the OCA = American Orthodox Church (former Russian Metropolia) mocked me, Fr Vasile Susan and my family, how very little people will included with their minds. However, where God is working, He overcomes the work of the opponent devil, because the Holy Bible says, **"But for God everything is possible."** (Matthew 19, 26).

Since I was kicked out of the Parish / Church of St Mary in Chicago, until the present time, I have written often to the Orthodox Church in America Synod of Bishops. I did numberless of appeals and calls, in accordance to the Romanian proverb which says, **"Knock the billboard and the deaf people will hear you."** Moreover, the OCA Bishops have trapped and snared me, as I fall upon, I cannot do anything. ***I was no great surprise, to realize that the traps they have prepared for me by the working of the crafty devil, the Good Lord has turned them in the opposite direction, and they just fell into them, as we will see it.***

Because I knew the truth from the beginning about the harassment made to me by the Archbishop / dictator and less honest leader from the Vatra Romaneasca, according to the knowledge I have had on the Canons of the Orthodox Church, OCA Statute and the Constitution and By – Laws of the ROEA, I let the things run on a very regular motion, making slavish obedience, and waiting that the time from **January 24, 2004, until April 26, 2005**, the Good Lord wanted to pass as quickly as possible. So it was!

Good relationships I have had with the faithful of the Church / Parish of St. Mary in Chicago, IL, at the time when I have been their priest, they are good today too, whenever we have a happy occasion to meet each other. All the Orthodox faithful in Chicago, as it was the whole ROEA, they were all unhappy by the dictatorial abuse of power and decision of the Archbishop / dictator and less honest leader of the Vatra Romaneasca to put me away from the Church / Parish, at the beginning of 2004 Great Lent, ***being less honest, or without showing reasons or allegations against my person or my working priesthood.***

Submission of the dossier to the Court of Chicago on April 26, 2005, brought big headache to those which have been part of the lawsuit: the ROEA, the ROEA Archbishop, V. Rev. Prot. Simion Pavel, Chicago, IL. Nobody has commented on anything, including me, although I was thrown from one dictator to another, from the Archbishop / dictator and less honest leader of ROEA, to the dictator and less honest Metropolitan of the OCA, + Herman. I understood my boss / master's sense, I did not upset him, but I've treated him with candor and without giving the possibility to pass, or to accuse and judge me unfairly.

The OCA Metropolitan +Herman, had no weapon, had not accused, blame, or had any reason to touch my working priesthood. To the contrary, + Herman, former Metropolitan of the OCA was kicked out in force on **September 4, 2008**, by the Synod of the OCA, as he put his hand up above the elbow, ... **and did not know how to account for OCA's money, as documents show over \$ 3,000,000.00, being accused of financial embezzlement, appropriation of money, together with a close associate of his position of responsibility posted in the OCA.** This is what the formerly OCA Metropolitan, named + Herman Swaiko has done, and the vast majority of American Orthodox Romanians and Americans, especially ROEA members do not want to know the truth and the let to be taken by the nose by incompetent and unscrupulous, less honest dictators.

**On August 9, 2005**, I sent a letter to the OCA Chancery, which asked to discuss my case during the OCA Synod meeting which had to be held between **October 18 - 20, 2005**.

**On August 11, 2005, and on September 22, 2005**, I, Rev Fr Vasile Susan have received written notice from the OCA Chancery, informing me about the fact that at the next meeting of the OCA Synod (**18 to 20 October 2005**), my case will be discussed and **"A" final decision will be taken by the bishops of the OCA.** Noting was really discussed, nothing was written in the minutes of the OCA Synod of that time, and not even today, as we shall see nothing from the OCA.

The Archbishop / dictator and less honest leader of the ROEA, after the OCA Synod meeting of October 18 to 20, 2005, knew that his lawyer in Chicago (which has so far spent over **\$ 100,000.00**, and costs related to the case of Father Vasile Susan), had to go to the Court in Chicago on **November 1, 2005**. Quail and upset-minded, the **Archbishop / dictator and less honest leader of the ROEA, on October 27, 2005**, was speaking on the phone and then he has written to the OCA Metropolitan and to the OCA Chancellor, **"BREATH – TAKING LETTER"**, as follows:

*"... I (Archbishop 'N'), have been contacted by our legal advisor from the Insurance Company, and he has asked certain questions which concerned me greatly. They have to do with Fr Susan's claim to not have been given proper consideration by the Church. I explain. He feels that he has followed the order for the redress according to the ROEA By – Laws; going through the Episcopate Council (see letters); anticipating action by the Holy Synod (see letter).*

*Our lawyer will try to get the case dismissed on the basis that this is a Church matter; however, there appears to be a snag ...*

*Father Rodion, I do not recall anything brought up nor I see anything in the minutes of the Holy Synod. It is imperative that some response be given to Fr Susan, otherwise he can verify that he received no redress from the Church and can appeal to the civil courts ...*

With blessings, Archbishop "N" ...

*(This document was sent by fax to the OCA on the day of Thursday, October 27, 2005, at 7:50 PM)*

This is **"the first document"** from which results **BLACKMAIL, LIES, EXTORTION, OBSTRUCTION OF JUSTICE and CORRUPTION of the Archbishop / dictator and less honest leader of the ROEA, in conspiracy with** the OCA less honest Metropolitan. The ROEA Archbishop's **"obstacle = SNAG"** he is talking about, is just **his denial and abuse of power shown to the rights that, I, Fr Vasile Susan, have asked to meet me under the provisions, procedures of the ROEA By - Laws.** ***Why the Archbishop / dictator, corrupt and less honest leader of the ROEA is afraid, he will not escape.***

Who can trust such Archbishop as dictator and less honest? Not me, Father Vasile Susan. ***Maybe the fools and cowards of the ROEA.*** God revealed the truth = the letter, and everyone is entitled to see / read it.

**On November 9, 2005**, the OCA less honest Metropolitan, +Herman writes, and sends to Rev Fr Vasile Susan the following:

*"Dear Father Vasile,*

*I have received your letter in which you request information concerning your complaints against His Eminence, Archbishop "N".*

*This is to inform you that you are to withdraw any and all complaints that you have filed against Archbishop "N" in civil courts. As you are aware, your actions in approaching a civil court are contrary to the canonical discipline and tradition of the Orthodox Church.*

*You will receive a response to your questions only after we have been notified that you have withdrawn the civil court suit against Archbishop "N".*

*+ Herman, OCA Metropolitan "*

This is "the second document" from which results **BLACKMAIL, LIES, EXTORTION, OBSTRUCTION OF JUSTICE and CORRUPTION of the OCA dictator and less honest Metropolitan +Herman, in conspiracy with** the Archbishop / dictator and less honest leader of the ROEA. Neither the OCA Metropolitan, nor the ROEA Archbishop, DOES KNOW the provisions and the procedures of the Orthodox Church Canons, the OCA Statute and ROEA By - Laws. *The OCA Metropolitan's less honesty, is that by blackmail he wanted to receive from me, (Fr Vasile Susan) a notarized letter for the OCA, to be used against me, to be made known in regards to the withdrawal of the civil lawsuit from the Court in Chicago against the ROEA, et al, for then to fool me much more.*

I, Rev Fr Vasile Susan, have lost my Church working place, job, parish priest assignment and all the benefits pension included, because I spoke **"OPENLY AND AGAINST" the Archbishop / dictator and less honest leader of the ROEA, who covered up the gay priest from OCA / ROEA for more than 20 years, as the priest's wife has written in her complaint - report sent to ROEA's Spiritual Consistory.**

Personally, *I have not had, nor have any canonical offense for which to be punished, but telling the truth, I was expelled, kicked out of ROEA, fired, sacked from the position of ministry as a priest, by the Archbishop / dictator and less honest leader of the ROEA, which believed that by terminating, firing, sacking, expelling me, everything will be over.*

I wish to tell him this way: because of your actions as of **March 1, 2004**, you have just begun **"the dance of Chardash and Kazachok"**; and you and your OCA cronies are dancing willingly or unwillingly; the naive and fools of the ROEA are paying (**plus \$ 100,000.00**), until the lawsuit is finished, and the justice served.

For almost seven years, I, Fr Vasile Susan, am asking the OCA Synod and Metropolitans, to comply with provisions and procedures of the Orthodox Church Canons, **to show me the charges, allegations against me, to bring me to a Church Court (ecclesiastical tribunal) and to give the right to defend.** They do not want to do what is written in the Orthodox Church Canons, OCA Statute, and ROEA By – Laws, because they cannot invent allegations and they are afraid of the Civil Court lawsuit.

Then, I ask you, dear readers of this article, **"Who is breaching (violating) all the provisions and procedures of the Orthodox Church Canons, the discipline and the tradition: I, Rev Fr Vasile Susan, or the Synod and the Metropolitan of the OCA?"**

The answer is: **only the OCA Synod. Rev Fr Vasile Susan requires compliance, and he fully respects and he is not afraid of knowing the truth.**

**Why the dictator, corrupt, and less honest OCA Metropolitan is afraid, he will not escape. How good, he was fired for financial embezzlement and other iniquities. God does not allow the OCA to be mocked till the Second Coming of our Lord Jesus Christ.**

*I have been instructed by His Beatitude, Metropolitan JONAH to communicate the following information to you. His Beatitude is bewildered by the nature of your recent postings. Nevertheless, he is asking you to consider the following:*

*1. His Beatitude again extends to you an invitation to come to the OCA Chancery to meet with His Beatitude to discuss some of the issues that you have brought forward in your e-mails. We would need to arrange this meeting at a time that would be convenient to both Metropolitan JONAH and yourself.*

*2. **His Beatitude would consider the possibility of assigning you to a parish if you would withdraw your lawsuit.** (Perhaps this would be something that you could discuss personally with the Metropolitan when you meet with him.)*

This is "the third document" from which results **BLACKMAIL, LIES, EXTORTION, OBSTRUCTION OF JUSTICE and CORRUPTION of the OCA less honest Metropolitan +Jonah, the OCA's Chancellor, the OCA Synod, in conspiracy with** the corrupt and untrustworthy OCA Synod, and the Archbishop / dictator and less honest leader of the ROEA.

All the OCA bishops (including Metropolitan) involved in such practices MUST RESIGN.

I, Rev Fr Vasile Susan, again wish to formally ask the OCA Synod, to launch an investigation and find out if **“ALLEGATIONS** (such as have been published on the Internet and also sent to the Synod of the OCA and hundreds of addresses) **ARE TRUE OR FALSE RATED.”** *I have asked for this investigation for (7) seven years, and also, I have asked the OCA Synod to follow the path: of the Orthodox Church Canons, of the OCA Statute, ROEA By – Laws, and Federal Laws and the Local State Laws of the American Federation, but the OCA Synod does not listen, and prefer to follow the law of the jungle, being irresponsible and liable to everything that happened to Rev Fr Vasile Susan and other priests.*

I, Rev Fr Vasile Susan, in the light of respect for God and His Orthodox Church, again wish to *formally, openly and transparently tell to the OCA Synod, “that I and my family are not ready and will never agree to any negotiated settlement, which is not right, honest, open, transparent, by law, unclassified, and finalized in the presence of my lawyer who represents me in the civil court proceedings.”*

Brothers and sisters in Christ the Lord, Dear readers of Curentul International,

From all the above, as well as from those materials posted on the Internet, you can see openly, *how petty, unclean, dishonest, without respect to God, His Orthodox Christian Church, Holy Bible, Orthodox Church Canons, OCA Statute, ROEA By - Laws, U.S. Laws, knowledge of truth, justice, fair trial, pastors, priests, lay Christians, etc* **“are all the bishops of the OCA and ROEA.”**
