Questions (95% of them) have been prepared ahead of time by me and they were addressed to V. Rev Fr. J. Jillions and E. G. Tosi. Notes have been taken by me and two other confident spiritual sons while I was talking to the Syosset priests on the cell phone's speaker.

Please read and reflect on the "FORMAL APPEAL TO THE OCA SYNOD and EXHIBITS" (**dated October 10, 2012**), and scheme orchestrated by some the "OCA hierarchs and OCA Central Administration personnel, against God, Justice, and me." **The OCA / ROEA homosexual sodomite priest (Rev Fr B.) was left to go to the WINDS ('DIOCESE OF THE WINDS' ... under the omophorion of whose Bishop ... According to the official OCA site / source (<http://oca.org/news/headline-news/metropolitan-council-meets-passes-budget-lowers-2013-assessments>) ... Members of the Metropolitan Council and the Lesser Synod of Bishops of the Orthodox Church in America held their fall session at the Chancery here Tuesday through Thursday, **September 25 - 27, 2012.**

Here there are some highlights related to the issue at stake ... Archpriest John Jillions, OCA Chancellor, provided an update on his work, especially in the area of sexual misconduct. The revised Policies, Standards and Procedures [PSP] is now being reviewed by legal concerns before general release. Because of the confidential nature of issues, Council members engaged in a lengthy discussion on current cases and procedures and issues affecting the life of the Church in executive session. This was directly followed by a report of General Counsel Thaddeus Wojcik and the Legal Committee, since a number of issues overlapped. The Committee provided an overview of the legal issues within the Church.

I personally feel very sorry for the fact that OCA Metropolitan Council members do not pay attention to the following statements from ... "(Chapter 7 ... from: Council Member Handbook as updated MC 2011.02.24 ... Fiduciary Responsibilities ... by Thaddeus Wojcik, OCA General Counsel) ... 'No man can serve two masters: for either he will hate the one, and love the other; or else he will hold to the one, and despise the other. Matt 6:24 (KJV)... as they were printed black on white ... Human nature has resulted in a complex labyrinth of laws in all aspects of human society.

Where there is a will (to do wrong) there is a way (to skirt a law). So, while a simple, fundamental statement of ethics or morals would likely be sufficient for a well-intentioned person to act in a fiduciary capacity, such a simple structure would be readily circumvented by the charming, crafty and cunning. So, not only is there a rather detailed code of rules set forth in the NFP Law and the Rel. Corp. Law, there is also a regularly growing body of case law interpreting and applying those statutes in various circumstances.

The law (just like self interest) is like a rubber band, being ever stretched to fit newly devised expressions of the timeless battle of right versus wrong. It is interesting to suppose, however, that at their heart, so many of the laws, rules, public policies, regulations, best practices and accountability standards that apply to religious corporations have their source in the same Lawgiver whose simple precepts we learned in Sunday School and during sermons: don't lie; don't cheat; don't steal; honor your promises; be wise as serpents but harmless as doves; and repent. It really is that simple, if you want it to be.

Let every person be subject to the governing authorities; for there is no authority except from God, and those authorities that exist have been instituted by God. Therefore, whoever resists authority resists what God has appointed, and those who resist will incur judgment. For rulers are not a terror to good conduct, but to bad. Do you wish to have no fear of the authority? Then do what is good, and you will receive its approval; for it is God's servant for your good. But if you do what is wrong, you should be afraid, for the authority does not bear the sword in vain! It is the servant of God to execute wrath on the wrongdoer. Therefore, one must be subject, not only because of wrath but also because of conscience. Rom 13: 1-5.

OCA hierarchy, Central Administration personnel, MC, SIC, SMPAC members,

As the time came for people mocked, used and abused by Jerry Sandusky of Pen State to see the justice served, so time is coming for 'the OCA to pay out the full price tag' for the 3 decades of unlawful mockeries and schemes done on OCA's clergymen and laity.

**Q:** Your Eminence, is it true, that you and the OCA Synod of Bishops covered up, offered a safe heaven and protected this notorious OCA / ROEA homosexual clergyman (Fr. B.) at least since 1990, and maybe for much more time, making mockery of me, my priesthood, my family, Fr. B.'s wife and family ...?

Your Eminence, please send openly and transparently your answers to the above questions. I'll enjoy in reading them.


