Dear in Christ the Lord,

It is about time to properly consider sending for posting to [www.pokrov.org](http://www.pokrov.org) some materials as a sign of our respect for the truth we would like to present and also for the revealing of cover up of malfeasances of the OCA / ROEA hierarchy.

Most of the biblical principles preached and observed by the Orthodox Church in America are just for those **WHO pray, pay and obey**. But, the same principles are for those in charge: **hierarchy as bishops, archbishops or metropolitans**.

Within the last 6 years, it was demonstrated by the OCA / ROEA hierarchy that there is a big contradiction between all biblical principles and their less - orthodox approach regarding the Christian principles and especially the TRUTH ... **"which will set us free" John 8, 32.**

The ocanews.org and pokrov.org, along with so many other sites demonstrated over the years, that "**WHEN the fish stinks from the head, the clean up process has to start from the head down**", not from the tail.

It is unfortunate that within the last two - three decades the OCA hierarchy (some hierarchs) did not practice what they preached, but the other way around, serving to the lord of darkness. **According to the Book of Acts 25, 7–12, St Paul was falsely accused, and requested emperor's trial ...**

<sup>7</sup>When he arrived, the Jews who had gone down from Jerusalem surrounded him, bringing many serious charges against him, which they could not prove. <sup>8</sup>Paul said in his defense, 'I have in no way committed an offence against the law of the Jews, or against the temple, or against the emperor.' <sup>9</sup>But Festus, wishing to do the Jews a favor, asked Paul, ‘Do you wish to go up to Jerusalem and be tried there before me on these charges?’ <sup>10</sup>Paul said, 'I am appealing to the emperor's tribunal; this is where I should be tried. I have done no wrong to the Jews, as you very well know. <sup>11</sup>Now if I am in the wrong and have committed something for which I deserve to die, I am not trying to escape death; but if there is nothing to their charges against me, no one can turn me over to them. I appeal to the emperor.' <sup>12</sup>Then Festus, after he had conferred with his council, replied, 'You have appealed to the emperor; to the emperor you will go.'

**Read also ... Acts 25, 16 – 21 ...** <sup>16</sup>I told them that it was not the custom of the Romans to hand over anyone before the accused had met the accusers face to face and had been given an opportunity to make a defense against the charge. <sup>17</sup>So when they met here, I lost no time, but on the next day took my seat on the tribunal and ordered the man to be brought. <sup>18</sup>When the accusers stood up, they did not charge him with any of the crimes<sup>\*</sup> that I was expecting. <sup>19</sup>Instead they had certain points of disagreement with him about their own religion and about a certain Jesus, who had died, but whom Paul asserted to be alive. <sup>20</sup>Since I was at a loss how to investigate these questions, I asked whether he wished to go to Jerusalem and be tried there on these charges.<sup>\*</sup> <sup>21</sup>But when Paul had appealed to be kept in custody for the decision of his Imperial Majesty, I ordered him to be held until I could send him to the emperor.'

**Read also, Acts 22, 25 – 30 ...** Up to this point they listened to him, but then they shouted, ‘Away with such a fellow from the earth! For he should not be allowed to live.’ <sup>23</sup>And while they were shouting, throwing off their cloaks, and tossing dust into the air, <sup>24</sup>the tribune directed that he was to be brought into the barracks, and ordered him to be examined by flogging, to find out the reason for this outcry against him. <sup>25</sup>But when they had tied him up with thongs,<sup>\*</sup> Paul said to the centurion who was standing by, ‘Is it legal for you to flog a Roman citizen who is uncondemned?’ <sup>26</sup>When the centurion heard that, he went to the tribune and said to him, ‘What are you about to do? This man is a Roman citizen.’ <sup>27</sup>The tribune came and asked Paul, ‘Tell me, are you a Roman citizen?’ And he said, ‘Yes.’ <sup>28</sup>The tribune answered, ‘It cost me a large sum of money to get my citizenship.’ Paul said, 'But I was born a citizen.' <sup>29</sup>Immediately those who were about to examine him drew back from him; and the tribune also was afraid, for he realized that Paul was a Roman citizen and that he had bound him.

<sup>30</sup> Since he wanted to find out what Paul<sup>\*</sup> was being accused of by the Jews, the next day he released him and ordered the chief priests and the entire council to meet. He brought Paul down and had him stand before them. “

Rev Fr Vasile Susan HAD / HAS “the RIGHT” to defend himself against any charges and to prove the INFIDELITY / FAILURE of the OCA / ROEA hierarchy to observe of the Church Canons, OCA Statute, ROEA Constitution and By – Laws, provisions, procedures. The employment issues do not fall under the 1<sup>st</sup> amendment's provisions, but the OCA / ROEA attorneys are less honest in civil courts, misleading the judges.**

Dear brothers in Christ as OCA / ROEA hierarchy,

Please STOP lying directly or indirectly through your legal counsels while facing the lawsuits in civil courts. Please **be FIDEL / LOYAL to the Gospel, Bible, Canons of the Orthodox Church, OCA Statute and ROEA Constitution and By – Laws provisions, procedures**, do not BETRAY ALL THE ABOVE, act in the Gospel's Spirit and Canons provisions, procedures' way, in timely manner.
